Subject: Decision on appeal against accreditation of MBA program of Indira Institute of Management, Maharashtra.

Sir,

This has reference to your letter dated 04.07.2014 filing appeal against the decision of NBA accrediting the MBA program of your Institute for a period of 3 years w.e.f on 06.05.2014, communicated vide NBA's letter of even number dated 22.05.2014.

2. The Appeal was considered by the Appellate Committee of NBA in its meeting held on 18.07.2014. The recommendation of the Appellate Committee was considered by the Sub-Committee of General Council of NBA at its meeting held on 06th August 2014. Based on the decision taken by the Sub-Committee, accreditation status of the program is given in the table below:

The accreditation status awarded to the program as indicated in the above table does not imply that the accreditation has been granted to Indira Institute of Management, Maharashtra as a whole. **As such the College should nowhere along with its name including on its letter head etc., write that it is accredited by NBA because it is program accreditation and not institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously.** Complete name and level of the program accredited and the period of validity of accreditation, as well as the date from which the accreditation is effective, should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.

4. The accreditation status of the above program is subject to change on periodic review, if needed by the NBA. It is desired that the relevant information in respect of accredited program as indicated in the table in paragraph 2, appears on the website and information bulletin of your College.

5. The accreditation status awarded to the program as indicated in table in paragraph 2 above is subject to maintenance of the current standards during the period of accreditation. If there are any changes in the status (major changes of faculty strength, organizational structure etc.), the same are required to be communicated to the NBA, with an appropriate explanatory note.
