## PERSONAL INTERVIEW ROUND FOR ADMISSION TO Ph.D. (MANAGEMENT) SAVITRIBAI PHULE PUNE UNIVERSITY

As per provision of University Circular No. 14/2017 dated 09/01/2017, schedule of personal interview for Ph.D. Admission shall be declared shortly by us on our website <a href="http://indiraiimp.edu.in/">http://indiraiimp.edu.in/</a> and also to the registered email address of the candidate.

## Instructions to the Candidates appearing for the interview:

- A. Eligible candidates are required to discuss their research interest/area before a duly constituted Selection Committee.
- B. The following aspects shall be considered during the interview, namely:-
  - 1. Whether the candidate possesses the competence for the proposed research;
  - 2. Whether the research work can be suitably undertaken at the Institution/College;
  - 3. Whether the proposed area of research can contribute to new/additional knowledge.
- C. The candidate shall produce all the required documents in ORIGINAL as mentioned in Notification dated 24/07/2017 along with one set of photocopy, including online application for M.Phil./Ph.D. PET Entrance Examination 2017-18, at the time of personal interview. Further, following documents in original and one copy duly attested wherever required, as applicable should be produced:
  - a. Original Result of PET Entrance Examination 2017.
  - b. Photo copy of UGC-NET (Including JRF) / UGC-CSIR NET (Including JRF) /SET / GATE (valid score) Certificate.
  - c. Photo copy of M.Phil. Degree Certificate of SPPU.
  - d. Photo copy of Marks/ Statement of Master's Degree.
  - e. Photo copy of the Caste Certificate in case of Reserved Category Candidates (if applicable).
  - f. Photo copy of the Non Creamy layer Certificate in case of Reserved Category Candidates (if applicable).
  - g. Photocopy of the Medical Certificate issued by Civil Surgeon in case of Persons with Disabilities (P.H.) candidates (if applicable).

- D. The candidates shall note the following:
  - a) They shall report at the centre One hour before scheduled time.
  - b) They have to appear before the panel on scheduled day and time only. In any circumstances, the late comers will not be allowed and there will not be any "out of turn" chance given to the late comers.
  - c) Candidates can appear for interview only once at the chosen research centre. Appearing for interview at multiple centres shall lead to disqualification of the candidate.
  - d) TA/DA will not be provided to the candidates for attending the interview.
