Instructions regarding Ph.D. Interview in the faculty of Commerce & Management

(A) MODE OF INTERVIEW

The main objective of the interview is to assess candidate's competencies and tenacity to take up research work for a longer period of time leading to the award of Ph.D. in Management.

The evaluation of the candidates will be based on the total marks (out of 50) obtained by them during interaction with the Panel of experts. The parameters will be as follows:

A. Competence for the proposed research.

A 1 Preparedness and aptitude for the proposed research (10 Marks)

A 2 Depth of understanding of subject (10 Marks)

- A 3 Domain experience related to research area (10 Marks)
- B. Suitability of proposed research to undertake at the research center (10 Marks)

C. Potential of contributing to new/additional knowledge (10 Marks)

Each candidate will be given around **10 – 15 minutes** for attending the interview during which she/he will have to present their ideas on proposed area of research and the research process.

Each candidate may be questioned on their perception about research, research process and subject matter etc. by the Panel members.

(B) INSTRUCTIONS TO THE CANDIDATES

- Candidates need to reach the venue of the interview at least one hour prior to the scheduled time
- 2. No out of turn requests will be entertained.
- 3. Candidates need to bring along the following documents, duly filed in a flat file, as per the sequence mentioned below, which need to be submitted to the Registrar, IIMP who will be checking your documents. Do not submit original documents, only copies, attested wherever required.

- i. 1 copy of the Information Sheet (mailed to all eligible candidates) duly filled in with photograph attached
- ii. Proof of Identity (Passport, ID card, License, etc.)
- iii. Attested copies of mark sheet and degree certificate (10th, 12th, UG, PG, MPhil., NET,SET)
- iv. Admit Card (if eligible through entrance examination)
- v. Copy of Ph.D. entrance test result
- vi. Candidates who have sought exemption from appearing for the PET are requested to submit attested copies of the relevant documents in support of their claim.
- vii. In addition to the above (v), exempted candidates should also submit a print out of declaration by SPPU of their eligibility of exemption.
- viii. Candidates applying against reserved categories need to submit attested relevant certificate.
- ix. Academic Gap Certificate (If arranged for)
- x. Transfer / Migration Certificate (If arranged for)
- 4. No TA/DA will be paid to any candidate.
- 5. Be sure to sign on the attendance sheet before going in for the interview.

Instructions to the candidates for Personal Interview for Ph.D. Admission 2022-23

In continuation with the Notification No. PGS/3820 dated 30/07/2022, PGS/4475 dated 15/09/2022, PGS/4742 dated 30/09/2022 and PGS/4778 dated 07/10/2022, the University through this notification hereby issues following directions for the information and compliance by all eligible candidates for Personal interview. (Qualified in Entrance Test/ Candidates exempted from Entrance Examination for Ph. D. Admission 2022).

As per provision of University Circular No. 14/2017 dated 09/01/2017, personal interviews shall be completed **before 30/12/2022** for Ph.D. admission. Detail scheduled will be declared shortly by all respective University Departments/Research Centres on their website/communicated through email to candidates.

Instructions to the Candidates appearing for the interview:

- Eligible candidates are required to discuss their research interest/area before a duly constituted Selection Committee.
 - The following aspects shall be considered during the interview, namely:
 - a) Whether the candidate possesses the competence for the proposed research;
 - b) Whether the research work can be suitably undertaken at the Institution/College;
 - c) Whether the proposed area of research can contribute to new/additional knowledge.
 - The candidate shall produce all the required documents in ORIGINAL as mentioned in Notification dated 15/09/2022 along with one set of photocopy, including online application for Ph.D. PET Entrance Examination 2022, at the time of personal interview. Further, following documents, as applicable for exemption of PET should be produced :
 - a) Result of PET Entrance Examination 2021.
 - b) Photo copy of UGC-NET (Including JRF) / UGC-CSIR NET (Including JRF) /SET / GATE (valid score), GPAT (valid score) Certificate.
 - c) Photo copy of Ph.D./M.Phil. Degree Certificate.
 - d) Other similar Certificates for exemption as notified in the notification.
- The candidates shall note the following:

- a) They shall report at the centre One hour before scheduled time.
- b) They have to appear before the panel on scheduled day and time only. In any circumstances, the late comers will not be allowed and there will not be any "out of turn" chance given to the late comers.
- c) Candidates can appear for interview only once at the chosen research centre. Appearing for interview at multiple centres shall lead to disqualification of the candidate.
- d) TA/DA will not be provided to the candidates for attending the interview.

Instructions to Research Centres for Personal Interview to Ph.D. Programme Admission 2022-23

In continuation with the Notification No. PGS/3820 dated 30/07/2022, PGS/4475, dated 15/09/2022, PGS/4742, dated 30/09/2022 and PGS/4778 dated 07/10/2022, following directions are issued for the information and compliance by all University Departments/Research Centres for Personal interview of eligible candidates qualified in Entrance Test/ Candidates exempted from Entrance Examination for Ph. D. Admission 2022.

All the University Departments/Research Centres should complete the interview process as per provision of circular No. 14/2017 dated 09/01/2017 before **30/12/2022** and display the date of interview on their website.

- **A.** The list of candidates eligible for personal Interview shall be made available to the respective Research Centres in their BOD Login.
- B. All the Research Centres shall fill up the vacant positions only as per vacant seats declared by the University on the University website. Final vacant position is available on University website.
- **C.** During the interview organized by the University Departments/Research Centres, the candidates are required to discuss their research interest/area before a duly constituted Selection Committee.

The following aspects shall be considered during the interview, namely:-

- 1. Whether the candidate possesses the competence for the proposed research;
- 2. Whether the research work can be suitably undertaken at the Institution/College;
- 3. Whether the proposed area of research can contribute to new/additional knowledge.
- D. The University Departments/Research Centres at affiliated colleges and recognized institutions/recognized research institutions shall obtain the approval of the Hon. Vice-Chancellor for the committee as mentioned in Circular No. 14/2017 dated 09/01/2017 immediately through their BOD Login. Attached herewith is the format of committee for Personal Interview as applicable to your research centre.

General Instructions:

A)

- The Head of the research centre shall follow the guidelines/norms given in the University Circular No-14/2017 Ref. No. PGS/144, dated 09th January, 2017 about fair and smooth functioning of interview process.
- All the University Departments/Research Centres shall send email/SMS to eligible candidates for personal interview.

- The Head of the Research Centre shall follow the State reservation policy while selecting the candidates.
- All the University Departments/Research Centres shall verify the documents of eligible candidates at the time of personal interview.

The Head of the Research Centre has to finalize the list of selected candidates and the allotment of guides to these candidates on the same day/days and forward the same along with panel report to P. G. Admission Section, Savitribai Phule Pune University, Pune within two days for approval. The Head of the concerned centre has to allot research guides to the selected candidates as per their area of interest or specialization. However, at the time of allotment of research guide, the concerned Head of the research centre has to consider the proper academic tuning/area of interest/specialization of the research guide and the research interest of the student.

- After all, it is the sole responsibility of the Head of the Research Centre to finalize the list of selected candidates in fair manner and in consultation with the expert committee.
- Once the approval to selected candidates and allotment of research guide is obtained, the Head of the concern centre has to give a time-bound programme/guidelines to all the candidates and research guides to expedite the process of making pre-registration presentation within the given deadline as per provision of the University circular No. 14/2017 dated 09/01/2017. This process is important for approving the research proposals by the RRC in a time bound manner.
